Etna Industrial Estate is located 2 miles South East of Motherwell Town Centre and 3 miles North East of Junction 6 of the M74.

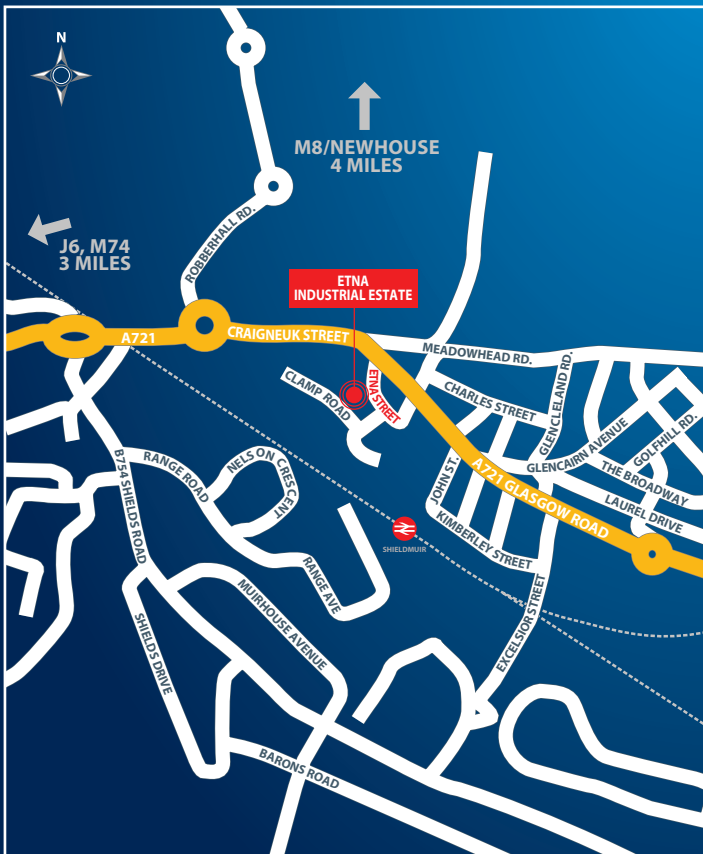
From Motherwell Town Centre, drive East along the A721 until you pass Motherwell College on the left and take the next right into Etna Street – the estate is on the right hand side.
